

Terms and Conditions

➤ The Competition

- The 7th edition of the International Clarinet Interpretation Competition is addressed to young instrumentalists who reach the maximum age of 35 by November 25, 2024, in the following age categories:

Category A – participants who are between the ages of 15-19 and completed by November 25, 2024

Category B – participants who are between 20-35 years old and completed by November 25, 2024

- Candidates who meet the age prescribed in category A, can compete in category B, assuming the requirements of this category.
- The organizers provide rehearsal rooms and an accompanist (for a fee) for participants who request this in the registration form.

➤ Registration fee

➤ Prizes

- The prizes will consist of money, musical instruments and accessories worth 7,000 Euros.
- Each participant will receive a participation diploma. The participants who go to the 2nd stage will receive the semi-finalist diploma. Participants who reach the final and are not awarded, receive the finalist diploma.
- The order of entry into the contest will be made by drawing lots, which will take place on November 25, 2024. If, at the time of the drawing, the participant is not present, his order number will be drawn by a member of the competition organizing committee.
- Competitors who won the first prize in previous editions do not have the right to participate in the competition.

➤ Jury

The jury will be made up of leading musicians from around the world.

The jury's decision is final and cannot be appealed.

The jury will decide the prizes to be awarded in each contest category.

The jury reserves the right to listen to the whole piece or only parts.

➤ Insurance

- The International Clarinet Interpretation Competition is not responsible for the costs of illness and/or accidents of candidates during their stay in Iasi.
- The International Clarinet Interpretation Competition is not responsible for loss/theft of goods personnel/musical instruments in the competition area.

➤ Broadcast

- By entering the competition, candidates agree that the organizers reserve the right to photograph and record (audio and video) all rehearsals, the final round and the concerts. They may be broadcast on radio, TV or online without further permission from the candidates or their companions, who are not entitled to claim any remuneration for these recordings and broadcasts.

➤ Personal data

- By registering for the competition, participants agree to the storage and use of their personal data by the Pro Musica Academica Association for the purpose of organizing the competition.

➤ Final provisions

In well-justified situations, the organizer reserves the right to make changes to any aspect of the competition. Any full or partial change in the place or time of the competition will be announced in due time. This includes the possibility to move the competition online in case of

force majeure, the application of restrictions on public events, restrictions on the movement of people or any other such measures imposed by government authorities for reasons of public health and safety.
